Purchasing Terms and Conditions

These terms and conditions of sale apply to all orders received. By placing an order you are deemed to have accepted these terms and conditions of sale. (Terms and Conditions are subject to change and therefore you are advised to print a copy of these terms at the time of ordering.)

Purchasing

To purchase items, please print an order form and send to the address detailed below together with the correct payment. A maximum of 5 items per order form may be placed without prior consent. Your order is an offer to buy the goods on these terms and conditions of sale.

The supply of goods is subject to availability. Whilst we always try to inform you if any goods are unavailable before you place an order, we cannot always do this. If this happens you will be informed by email and refunded for any unfulfilled items.

Prices

All prices of goods available are quoted and charged in sterling. VAT is not charged at present. Prices remain unchanged, with the exception of any unexpected price or VAT changes.

Forms of Payment

Currently we can only accept payment by cheque or postal order. Cheques should be made payable to 'Headway Essex'. It is not recommended to send cash in the post.

Delivery

Orders will normally be dispatched free of charge within 28 working days from receipt of your order, via Royal Mail (standard delivery).

Collection can be made in person, by prior appointment. Please contact to arrange.

Orders outside of the UK must be purchased online only at www.headwayessex.org.uk

Cancellations and Refunds

With all sales, if it is necessary to cancel your order, please contact us as soon as possible by phone or email headed up "Order Cancellation". If goods have already been dispatched a charge may be incurred.

Your right to cancel does not apply:-

To goods you have used and which are therefore not in a saleable condition.

To all goods or services, if you are acting in the course of business.

You have a statutory right to cancel your order by notifying us in writing within 7 working days of delivery.

If you have received your goods and need to cancel your order and claim a refund, write to us at the "returns address" below within 7 working days from delivery, heading your letter "Order Cancellation" and send the goods back, in a saleable condition. A 'working day' is any day which is not a weekend or a bank holiday. We will refund the purchase price to you within 30 days of your cancellation notice. You are responsible for the costs of returning the goods and this cannot be refunded.

Please note that we are unable to cancel any orders after the 7 working day period unless the goods are faulty (see 'Faulty Goods' below). Your right to cancel is separate from other statutory rights you may have.

Faulty Goods

If any goods ordered from us are faulty, please return them to the address below as soon as possible, securely packaged. If we find that the goods are faulty, and you have returned them within a reasonable period, we will refund the purchase price and your postage costs for returning the goods (standard delivery). This refund policy does not affect your statutory rights.

Replacement Goods

Whilst every effort will be made to replace goods, it must be noted that due to the limited nature of some of the goods supplied, we cannot guarantee to replace any returned items.
